18.30	Panel Discussion	
	 ST shared that it was brilliant to see so many things going on in Camden, despite the uncertain circumstances, and it's exciting to be a part of it all. 	
	 PC raised the point that air quality must have improved during lockdown, yet it seems as soon as society reopens air quality worsens again and we don't seem to learn. HG explained that the Council are working on an online air quality 'lesson' as part of Camden's Mayor of London <u>'Engines Off'</u> campaign. 	HG CQ
	 PC explained that many schools have eco-champions, usually a teacher that is sustainably driven and then therefore takes the lead on driving campaigns via school leadership and school communities, however this tends to be in addition to the day-to-day. Everyone is so busy at present, it's all hands-on deck and difficult to get anything else done. Delaying the info campaign is a good thing for now. 	
	 CQ shared the difficulties in maintaining strong relationships in schools due to teachers changing, therefore it becomes a process of starting from scratch to re-engage. It is especially difficult now with competing priorities; however, the Schools Climate Charter might help to reframe the climate agenda as a priority for schools whilst in keeping with other important priorities. PC agreed it's difficult to break the cycle but repeating the process is key. PC asked do we have a list of schools in the borough where we don't have contacts? In response to the difficulties around maintaining meaningful long-standing relationships with schools and teachers, BR proposed that we engage Trustees or Parent Governors as part of the school's sustainability approach. HG confirmed that we are aiming to include the Schools Sustainability Charter in the Governor training which is provided to all new school governors. BR also asked if <u>Groundwork</u> have projects for Children and families? This could help with schools and establishing the longer-term presence. NM said that home schooling parents might welcome a structured sustainability focused project and that this could perhaps be something that is published in the CNJ over the course of a few weeks, and it follows on from the 'wrap', encouraging less of a reliance on screen time. CQ explained if we can raise the profile of the Climate Charter through communities, schools, e-bulletin etc. then the school can make a commitment, taking away the pressure from one individual. PC explained it was important to be mindful of projects that schools are already involved with e.g. <u>TfL STARS</u> 	CQ
	programme, eco-schools, and how it is important to keep everything as administratively low as possible as teachers don't have time for these tasks. PC agreed that placing the focus on the school not an individual is good. CQ shared that these concerns had been raised by teachers in the peer support group. CQ reassured that the charter isn't another framework, it is a declaration/commitment that can help bring awareness to how schools are already responding and encourage the sharing of information and knowledge with other schools to form part of a network.	
	 BR proposed could a connection be made with schools feeding children and families in poverty and linking this in with Camden's climate change actions, to help educate families on how interconnected they are. Is there 	CQ



	scope to keep the discussion alive through the free school's food voucher scheme? PC echoed that this was a great idea. JM shared the link: https://www.incredibleedible.org.uk/ .	
•	JM shared that it was exciting to see the discussions from the last session had really been taken on board and reflected in the content of the update presentation and is testament to the ability to have this dialogue between the panel/Council.	
•	JM said it was clear to see how much noise and competition there is for driving awareness of the climate agenda. JM asked could there be scope for the Renewal Commission to provide the overarching narrative/framework for people to understand that the climate crisis isn't a distraction from the covid crisis or	HG CQ JB AR

•	JM explained that a new volunteer is working with <u>Power Up North London</u> (PUNL) to help provide extra capacity to help schools improve the way they use their buildings. PUNL have submitted funding to the Mayor of London climate fund to make this a paid role. JM explained it's difficult for people to find time in addition to their day jobs to think about these complex issues, and to provide a little bit of extra capacity can make such a difference for a relatively small cost. •	CP asked how Camden are planning to measure success for all the actions listed under the 'People' section. Who are the different actors being engaged with e.g. schools, universities, communities etc. and what activities are they being targeted with? Is there a map that can help visualise who is being targeted with what and if those activities are being successful? It could help to identify ways to be more adaptive and understand short term and longer-term activities, as well as developing partnerships. JM agreed developing partnerships would help with metrics. CP explained the panel could help to think through what the success measures are and provide	
•	Who are the different actors being engaged with e.g. schools, universities, communities etc. and what activities are they being targeted with? Is there a map that can help visualise who is being targeted with what and if those activities are being successful? It could help to identify ways to be more adaptive and understand short term and	



targeting a specific community with a specific behaviour. Ideally, there would be campaigns running in parallel at
different levels, something more general overall, with smaller, more focused campaigns to support delivery and
impact. CQ is working to develop the scope of metrics and impact within the campaign plan with an external
agency.

- AW asked if there was a way that sustainability could be embedded in schools through enforcement at a higher level e.g. Department for Education, so that a formal arrangement is introduced into all schools requiring them to respond to the climate crisis in line with Camden Council's climate emergency declaration. This could then help to foster climate teams within schools and parent groups and give the organic growth described in the update presentation a greater platform. WS and PC agreed, with PC further elaborating that until there is a paid position in each school, essentially, we're relying on everyone's good will and whilst faced with a global pandemic, climate is pushed to one side. Even in the running of schools day-to-day, sustainability isn't at the top of everyone's list and it requires a national effort. CQ explained that there had been discussions about this with Camden Learning, however embedding sustainability across the curriculum requires a lot of lobbying and change at a higher level than the Local Authority.
- AW suggested it would be great to align ideas in the CNJ visioning with what the council want to do not everything needs to be done at once, even if only parts of campaigns are delivered e.g. the challenges we face coming out of covid, such as transport e.g. volumes of people using transport, people flying again etc.
- CQ reassured that the council works closely with community groups e.g. Think and Do, Transition Kentish Town etc. and they are aware projects must align with the vision of the Climate Action Plan to gain council support due to resource.
- JM said it would be great to think ahead to the positive messages that greet us in the spring e.g. travel, greening, revitalising local business. ST agreed that there was an opportunity to reframe the comms by leading with a cause or issue such as food waste, food sharing, travel and how this in turn impacts carbon emissions and marginalised BME groups.
- JM suggested a network of school orchards as part of the 2021 renewal.
