**Fitzjohn's Avenue**, NW3: opposite the junction of Maresfield Gardens replacing 5 metres of paid-for parking space.

**Greenland Street**, NW1: remove existing electric vehicle bay at junction of Bayham Street and replace with at any time waiting and loading restrictions. Convert 5 metres of paid-for parking space outside nos. 2 to 6 Greenland Street to electric vehicle parking space.

**Hampstead Grove**, NW3: adjacent to current car club parking north of the junction of Upper Terrace replacing paid-for parking space.

Herbrand Street, WC1N: outside nos. 1 to 15 Bernard Mansions, Herbrand Street replacing most northerly car club space.

**Holmes Road**, NW5: approximately 30m north-west of the junction of Spring Place replacing 5 metres of paid-for parking space.

**Kelly Street**, NW1: adjacent to car club only parking north of no. 98 Castlehaven Road replacing one resident permit parking space.

**Lambolle Place**, NW3: opposite no. 18 Lambolle Place replacing 5 metres of paid-for parking space.

**Lancaster Grove**, NW3: opposite no. 35 Lancaster Grove replacing 5 metres of resident permit parking space.

**Lindfield Gardens**, NW3: outside no. 2b Lindfield Gardens replacing 5 metres of resident permit parking space.

**Maresfield Gardens**, NW3: adjacent to no. 42 Netherhall Gardens replacing 5 metres of resident permit only parking space.

**Mill Lane**, NW6: outside no, 64 Mill Lane replacing 5 metres of paid-for/permit holder parking space.

**Netherhall Gardens**, NW3: opposite no. 11 Netherhall Gardens replacing 5 metres of resident permit parking space.

**Ornan Road**, NW3: opposite no. 2 Ornan Road replacing 6 metres of resident permit parking space.

**Osnaburgh Street**, NW1: at southern end of taxi rank replacing paid-for parking space.

**Ospringe Road**, NW5: adjacent to no. 50 Lady Margaret Road convert 5 metres of resident permit parking space.

**Regent's Park Road**, NW3: adjacent to current electric vehicle bay opposite no. 110 Regent's Park Road replacing 5 metres of paid-for/permit holder parking space. **Swain's Lane**, NW5: north of the junction of Langbourne Avenue replacing 5 metres of permit holder parking space.

**Templewood Avenue**, NW3: opposite no. 17 Templewood Avenue replacing 5 metres of permit holder parking space
