

Transport Strategy Privacy Notice

Transport Strategy works to deliver Safe and Healthy Streets in Camden. The Covid-19 pandemic has changed how people in Camden live, travel and work. We want our streets to have more safe space for everyone to walk and cycle, for children to get to and from school safely and healthily, for businesses to be able to flourish, to reduce carbon emissions from vehicles and for you to be breathing cleaner air.

We want to ensure that our streets support a strong recovery from the pandemic and provide a lasting legacy of greener, safer, healthier travel. Whether it's an essential journey like taking your children to school, getting to work or just popping out to enjoy your local park we want you to love where you live, and to love Camden.

To meet these aims we want to hear from the people who use our streets so that their views can feed in to how we make decisions on the changes we make. To do this we run consultations (often on <u>we are Camden</u>) as well as asking for informal feedback (often on <u>commonplace</u>). As part of this we need to collect your personal data to help us understand your relationship to the streets you are commenting on and how any changes we are proposing might affect you. When we ask about special category data like your gender identity or age these are always voluntary questions.

This privacy notice will explain how the Transport Strategy team uses your personal data collected when you comment on either one of our consultations or on Commonplace. What information do we collect?

Transport Strategy collects the following data:

- Personal data (name, email address, home address, telephone, and if the user decides to provide it their age,)
- Special category data can be collected on We are Camden and commonplace if the user completes them. This includes: gender, gender identity, ethnicity, religion, disability, sexual orientation, relationship status, dependents, pregnancy.

How do we collect your data?

You will be asked to provide your data when you:

- Take part in a consultation or give your feedback on Commonplace
- At meetings, focus groups or other in person gathering

How will we use your data?

We collect your data so that we can:

- Use it to help us make decisions on the changes we make on streets. The analysis of the data from consultations is however only one aspect which helps us in our decision making. The views of everyone who contributes to a consultation or engagement piece are analysed and considered, alongside relevant data available on the scheme and in light of how the scheme aligns with our current policy objectives, in order to put forward recommendations on whether to proceed with the proposals.
- Use the information in our reports but all personal details will remain confidential.
- Understand if our trial changes on street are changing people's opinions on what they think of potential changes which helps us to better plan for trials in the future and improves how we communicate.

Legal Basis

For personal data this is UK GDPR Article 6(1)(e) (public task) and for special category (sensitive) data it is article 9(2)(g) (public interest) with the Data Protection Act Schedule 1 Part 2 condition being para 6 Statutory and government purposes and the underlying law being the Equality Act 2010 under which the public is protected from unlawful discrimination if they have the following protected characteristics; age, marriage and civil partnerships, race, religion and belief, sex, gender reassignment, sexual orientation, disability and pregnancy and maternity.

Under that Act the Council also has a duty to have due regard to the need to take steps to eliminate discrimination against, and promote equality of opportunity for, persons who share a relevant protected characteristic as compared with those who do not share it.
