Made on 25<sup>th</sup> April 2016

Coming into force on 2<sup>nd</sup> May 2016

The Council of the London Borough of Camden, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 9 of the Road Traffic Regulation Act and of all other powers thereunto enabling, hereby make the following order:

## 1. Citation and commencement

1.1 This order shall come into force 2<sup>nd</sup> May 2016 and may be cited as the Camden (Prescribed Routes, Waiting and Loading Restrictions and Parking Places) (No. 1) (Amendment No. 1) Experimental Traffic Order 2016.

#### 2. Interpretation

- 2.1 In this order the following terms have the meanings ascribed respectively to them:
- <sup>2.1.1</sup> "experimental order" means the Camden (Prescribed Routes, Waiting and Loading Restrictions and Parking Places) (No. 1) Experimental Traffic Order 2015;
- 2.1.2 any reference in this order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment;

#### 3. Modifications to the Experimental Order

- 3.1 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this order the experimental order shall have effect as though;
- articles 3.6, 3.7 and 3.8 were omitted;
- 3.1.2 article 3.9 amended to 'Any person causing any motor vehicle to proceed northwards in Woburn Place shall, on reaching the junction with Tavistock Place and Tavistock Square, cause that vehicle to continue to proceed northwards past the junction; non-motorised bicycles are permitted to turn left
- 3.1.3 the word "motor" was inserted before "vehicle" in articles 3.11 and 3.13;
- 3.1.4 the following sub-articles were included after sub-article 3.1.13;

- 3.1.14 No person shall cause any motor vehicle to turn right from the south-western arm of Gordon Square into Byng Place
- 3.1.15 No person shall cause any motor vehicle to turn left from either the north-eastern or south-western arms of Torrington Square into Byng Place;
- 3.1.16 No person shall cause any motor vehicle to turn left from either the north-eastern or south-western arms of Woburn Square into the south-eastern arm of Gordon Square;
- 3.1.17 No person shall cause any motor vehicle to turn right out of Gordon Square from between the junction of Byng Place / Gordon Square until past the junction with Woburn Place.
- 3.1.4 The following text is substituted for Article 5 of the experimental order:

#### 5. Exemptions

- 5.1 Nothing in Article 3 shall apply:
- 5.1.1 in respect of anything done with the permission or at the direction of a police officer in uniform;
- 5.1.2 to any vehicle being used for ambulance, fire brigade or police purposes in an emergency;
- 5.1.3 to any person causing any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to sections 66 and 67 of the Road Traffic Regulation Act 1984;
- 3.1.5 The schedule to this order is substituted for the schedule to the experimental order.

## 6. Power to modify or amend this order

6.1 Pursuant to Section 10 (2) of the Act of 1984, Director of Culture and Environment, Transport Strategy Service or any person authorised by him may, if it appears to him or such other authorised person essential in the interest of the expeditious, convenient and safe movement of traffic, or in the provision of suitable and adequate parking, or for preserving or improving the amenities of the area through which any road affected by this order runs, modify or suspend this order or any of the provisions in this order.
