**HILLFIELD ROAD, NW6:** Removal of a 5.3 metre section of the permit holders parking place opposite no. 38 Hillfield Road. Removal of the dedicated disabled parking place opposite no. 42 Hillfield Road and conversion to permit holders parking.

#### **Statement of Reasons**

There is a growing demand from residents living in high density dwellings, with limited space for sheltered and secure cycle parking within their properties.

A lack of secure cycle hangar storage facilities is currently a barrier to people to cycle. A key objective of the Camden Transport Strategy is to improve cycling facilities for those both living, visiting and working in Camden.

The Council believes the introduction of secure cycle hangar parking facilities would encourage the use of cycling within the borough especially in locations where high density dwellings are present.

#### 1. Citation and commencement

1.1 This Order shall come into force on and may be cited as The Camden (Revocation of Parking Places) (No. 1) Traffic Order 2020.

- 2.2 Any reference in this order to any other order or enactment shall be construed as a reference to that order or enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent order or enactment.
- 2.3 Unless the context otherwise requires, any expression used in this order which is also used in the parent order shall have the same meaning as in that order.
