#### The Camden (Prescribed Routes) (No. 5) Traffic Order 2020

Notice is hereby given that the Council of the London Borough of Camden proposes to make the above Order under Sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the order will be to prohibit certain vehicle movements in Tottenham Court Road and side streets, Gower Street and side streets and in Shaftesbury Avenue and nearby streets.

In general, the measures will limit the daytime use of Tottenham Court Road northbound and southbound by prohibiting through traffic between 8am and 7pm on Mondays to Saturdays. Sections of Tottenham Court Road may be accessed from side streets but traffic will be required not to proceed past certain junctions and turn into those side streets. Uninterrupted north and southbound travel at all times is provided via Gower Street, Bloomsbury Square (east arm) and Bloomsbury Street which become two-way working.

The two eastern arms of Shaftesbury Avenue, north of High Holborn, will be closed to through traffic (i.e. the arm which lie adjacent to nos. 210-236 Shaftesbury Avenue and the arm which lies adjacent to the Shaftesbury Theatre). Access to from premises located at nos. 210 – 236 (even numbers) Shaftesbury Avenue will be provided by a traffic lane running from the junction with West Central Street to the junction with Grape Street. The two western arms of Shaftesbury Avenue will become two-way working to provide a through route for traffic travelling in both directions between the junctions with Bloomsbury Street / New Oxford Street and High Holborn / St. Giles High Street and to provide a continuation of the direct north-south route via Gower Street.

High Holborn will become two-way working between the junctions with St. Giles High Street and Museum Street in order to maintain convenient access to Endell Street in the absence of an available route via the eastern arms of Shaftesbury Avenue.

#### TOTTENHAM COURT ROAD: restrictions applicable between 8am and 7pm on Mondays to Saturdays:

- Northbound vehicles not to proceed past the junction with Great Russell Street / Hanway Street (vehicles must turn into either street)
  - vehicles not to proceed past the junction with Howland Street (vehicles must turn left)
- Southbound vehicles not to proceed past the junction with University Street (vehicles must turn left) vehicles not to proceed past the junction with Alfred Mews (vehicles must turn left) vehicles not to proceed past the junction with Chenies Street (vehicles must turn left)

#### All other prescribed movements specified below apply at all times

#### SHAFTESBURY AVENUE

Vehicular entry prohibited at all times to the section of Shaftesbury Avenue which run south-west from the junction with Coptic Street adjacent to nos. 210-236 Shaftesbury Avenue, and the section which lies adjacent to the Shaftesbury Theatre (the eastern arms). Cyclists are exempted from this restriction. A lane for vehicles will be provided between the junctions with West Central Street and Grape Street along which vehicles must proceed from north-east to south-west only.

Vehicles will be permitted to travel both in both directions along the section of Shaftesbury Avenue which lies adjacent to the Bloomsbury Central Baptist Church and the section which lies adjacent to nos. 219-229 Shaftesbury Avenue.

#### WEST CENTRAL STREET

Traffic to proceed in one direction only, from the junction with Museum Street towards the junction with Shaftesbury Avenue

#### **HIGH HOLBORN**

Vehicular traffic to be permitted to proceed eastwards in High Holborn between the junctions with St. Giles High Street and Museum Street. Vehicles travelling eastwards must not proceed past the junction with Museum Street and must turn left.

# The Camden (Prescribed Routes) (No. 1) Traffic Order 2020

## **Statement of Reasons**

The measures form a part of Camden's West End Project and would see the curtailment of through traffic, except local buses and cycles, along Tottenham Court Road on Mondays to Saturdays between 8am and 7pm. Access to premises along sections of Tottenham Court Road during these times will be preserved via side streets.

The eastern arms of Shaftesbury Avenue (i.e. the lengths which lie adjacent to nos. 210-236 and adjacent to the Shaftesbury Theatre), will be closed to all traffic except cycles, at all times. Access to premises will be preserved by constructing a traffic lane between the junctions with West Central Street and Grape Street.

A direct north to south route in both directions is maintained along Gower Street, Bedford Square, Bloomsbury Street and Shaftesbury Avenue. Traffic heading towards Bloomsbury Way which may formerly have used the eastern arms of Shaftesbury Avenue is provided for by designating High Holborn as two-way working between the junctions with St. Giles High Street and Museum Street.

West Central Street is designated as one-way working (generally from east to west).

The Council of the London Borough of Camden, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 6 and 124 of and part IV of schedule 9 to the Road Traffic Regulation Act 1984 [1984 c. 27], as amended by section 8 of and part I of schedule 5 to the Local Government Act 1985 [1985 c. 51], and of all other powers thereunto enabling, hereby make the following order:

### 1. Citation and commencement

1.1 This order shall come into force on and may be cited as the Camden (Prescribed Routes) (No. 5) Traffic Order 2020.

## 2. Interpretation

- 2.1 In this order,
- 2.1.1 any reference to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 2.1.2 the terms "pedal cycle" and "local bus" have the same meanings ascribed to them as by the Traffic Signs Regulations and General Directions 2016 [S. I. 2016 No. 362].
- 2.1.3 references to tables and columns shall mean the respectively numbered tables and columns in the schedule to this order.
- 2.1.4 the term "eastern arms of Shaftesbury Avenue" shall mean the section of Shaftesbury Avenue which is adjacent to nos. 210-236 Shaftesbury Avenue and the section which is adjacent to the Shaftesbury Theatre.
- 2.1.5 the term "Shaftesbury Avenue" shall be construed to mean any part of Shaftesbury Avenue excluding the eastern arms of Shaftesbury Avenue.

## 3. Revocations

## 4. Restrictions

- 4.1 No person shall cause any vehicle proceeding in the street and, if indicated, in the direction specified in column 2 of an item in table 1 to turn right into the street specified in column 3 of the same item.
- 4.2 No person shall cause any vehicle proceeding in the street and, if indicated, in the direction specified in column 2 of table 2 to turn left into the street specified in column 3 of table 2.
- 4.3 The restrictions set out in Articles 4.1 and 4.2 shall not apply in respect of any class of vehicle set out in column 4 of the respective item.
- 4.4 Any person causing a vehicle to proceed in the street specified in column 2 of table 3 shall cause that vehicle to proceed only in the direction specified in column 3 of table 3.
- 4.5 No person shall cause any vehicle proceeding northwards in Tottenham Court Road, other than a pedal cycle or local bus, to proceed past the junction with Great Russell Street and Hanway Street between the hours of 8am and 7pm on Mondays to Saturdays.
- <sup>4.6</sup> No person shall cause any vehicle proceeding northwards in Tottenham Court Road, other than a pedal cycle or a local bus, to proceed past the junction with Howland Street between the hours of 8am and 7pm on Mondays to Saturdays.
- 4.7 No person shall cause any vehicle proceeding southwards in Tottenham Court Road, other than a pedal cycle or a local bus, to proceed past the junction with University Street between the hours of 8am and 7pm on Mondays to Saturdays.
- <sup>4.8</sup> No person shall cause any vehicle proceeding southwards in Tottenham Court Road, other than a pedal cycle or a local bus, to proceed past the junction with Alfred Mews between the hours of 8am and 7pm on Mondays to Saturdays.
- 4.9 No person shall cause any vehicle proceeding southwards in Tottenham Court Road, other than a pedal cycle or a local bus, to proceed past the junction with Chenies Street between the hours of 8am and 7pm on Mondays to Saturdays.
- <sup>4.10</sup> No person shall cause any vehicle, other than a pedal cycle, to enter the eastern arms of Shaftesbury Avenue except for any motor vehicle proceeding from northeast to south-west in the lane provided for vehicular traffic between the junctions with West Central Street and Grape Street.
- 4.11 Any person causing any vehicle to proceed eastwards in High Holborn, on reaching the junction with Museum Street shall cause that vehicle to turn left.

# 5. Other exemptions

- 5.1 Nothing in Article 4 shall apply in respect of;
- anything done with the permission of a police constable or traffic warden in uniform;
- 5.1.2 a vehicle being used by the police, ambulance service or fire brigade in an emergency;
- 5.1.3 any person causing any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to Section 66 or 67 of the Road Traffic Regulation Act 1984.
