A section of the permit holders parking place outside no. 6 Cleve Road is being removed in order to accommodate a vehicular crossover to the same property.

- 1. From a point level with the common boundary of 6 and 8 Cleve Road (single yellow line zone hours) for a distance of 4.1 metres eastwards
- 2. From a point 4.1 metres east of the common boundary of 6 and 8 Cleve Road (Resident Permt Holders Only) for a distance of 5.6 metres
- From a point 9.7 metres east of 6 and 8 Cleve Road (single yellow line zone hours) for a distance of 3.1 metres eastwards (note that this should match the existing single yellow line.

#### 1. Citation and commencement

1.1 This Order shall come into force on and may be cited as The Camden (Parking Places) (CA-R) (Amendment No. 19) Traffic Order 2020.

#### 2. Interpretation

- 2.1 In this order:
- the term "parent order" means the Camden (Parking Places) (CA-R) (Traffic Order 2012 [L.B.C 2012 No. 16];
- 2.1.2 any reference in this order to any other order or enactment shall be construed as a reference to that order or enactment as amended, applied, consolidated, reenacted by or as having effect by virtue of any subsequent order or enactment;
- 2.1.3 unless the context otherwise requires, any expression used in this order which is also used in the parent order shall have the same meaning as in that order.

#### 3. Revocation and designation of parking places

- 3.1 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this order the parent order shall have effect as though:
- 3.1.1 there was omitted from schedule 1 to the parent order, the item set out in table 1 of the schedule to this order;
- 3.1.2 there was included in schedule 1 to the parent order, the items set out in table 2 of the schedule to this order.
