#### The Camden (Permit Parking Places for Electric Vehicles) Traffic Order 2021

Notice is hereby given that the Council of the London Borough of Camden proposes to make the above order under Sections 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the order will be to designate parking places as detailed below reserved for the purposes of re-charging the batteries of "plug-in" electric or hybrid vehicles in respect of which a valid residents, business or visitors permit has been issued. The parking places will be restricted "at all times". Vehicle batteries must be continuously re-charging whilst parked with an overall maximum stay of 12 hours being permitted. Vehicle batteries may only be charged by connection to the charging point already installed in a lamp column adjacent to the proposed parking place.

## STATEMENT OF REASONS

In order to encourage the use of electric vehicles for essential trips that require motor vehicles (by improving access to electric vehicle charge points), we are proposing to convert parking spaces adjacent to thirty lamp column electric vehicle charge points in Camden to 'electric vehicle charging only' parking spaces, for permit holders at all times.

This will contribute to meeting the Camden Transport Strategy (2019 – 2041) objective of reducing and mitigating the impacts of transport based emissions and noise in Camden.

Additionally, by facilitating a switch to the least polluting vehicles, it is anticipated that the proposals will contribute to delivering:

- The key priority of the Camden Clean Air Action Plan (2019 2022) of reducing transport emissions;
- The target of reducing all carbon dioxide emissions associated with fuel consumption within the boundary of the borough to zero by 2030, as set out in the Camden Climate Action Plan (2020 2025).

#### 1. Citation and commencement

### 3. Amendments to the parent orders

"plug-in electric vehicle" means a vehicle in which the vehicle's motive power is solely or partially derived from an electrical storage battery which is not connected to any source of power when the vehicle is in motion and which is capable of being connected to an existing power source provided adjacent to the parking place for the purposes of charging the vehicle's battery. "charging infrastructure" means apparatus provided adjacent to a parking place designated in Schedule 4 for the purposes of charging a plug-in electric vehicle's battery by the connection of a cable between the charging infrastructure and the plug-in electric vehicle.

- 3.2 The parent orders shall have effect as though there was included under the title "SCHEDULES" in the first page of those orders after item 3 the following text:
  "4 Parking Places for use by plug-in electric vehicles whilst charging"
- 3.3 The parent orders shall have effect as though there was inserted the following text between Articles 4 and 5.

# 4A Designation of parking places for use by plug-in electric vehicles whilst charging

- <sup>4A.1</sup> Each parking place referred to in Schedule 4 may be used, subject to the provisions of this Order for the leaving during the controlled parking period only of such vehicles or motorcycles that are plug-in electric vehicles and, in respect of which, a permit issued under the provisions of Articles 6, 7, 8, 9 or 10 of this order, has been issued.
- <sup>4A.2</sup> No plug-in electric vehicle shall be left in a parking place designated in Schedule 4 without the vehicle being connected to the charging infrastructure and unless the battery of the vehicle is being charged at all times whilst left in the parking place by the flow of electrical current from the charging infrastructure to the battery of the vehicle.
- An indication that the battery of the plug-in electric vehicle is being charged shall be given by the vehicle being physically connected to the charging infrastructure by a cable and the illumination of a coloured light on the charging infrastructure's control panel to show that current is flowing from the charging infrastructure to the vehicle.
- <sup>4A.4</sup> A plug-in electric vehicle shall not be left in a parking place designated in Schedule 4 for a period of more than 12 hours.
- <sup>4A.5</sup> No plug-in electric vehicle which has been taken away from a parking place designated in Schedule 4 shall, until the expiry of a period of 2 hours from the time it was taken away may be left again in that parking place.

## 3. Revocation and designation of parking places

- 3.1 Nothing in this article shall prejudice the validity of anything done or any liability incurred in respect of any act or omission before the coming into force of this order.
