The Camden (Waiting and Loading Restrictions) (Amendment No. 123) Traffic Order 2021

Notice is hereby given that the Council of the London Borough of Camden proposes to make the above Order under Section 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the order will be to designate waiting prohibitions applying at all times at the junctions specified below for distances of between approximately 10-15 metres from the junction with the neighbouring road. No parking places are affected by these proposals which consist of conversions of single yellow line to double yellow line or extensions of pre-existing double yellow line restrictions.

ADELAIDE ROAD / BRIDGE APPROACH – south side of Adelaide Road for approximately 10 metres west from the junction with Bridge Approach.

BELSIZE LANE / WEDDERBURN ROAD – west side of Belsize Lane for approximately 10 metres south from the junction with Wedderburn Road; east side of Belsize Lane between the two residents' parking places outside and at the side of no. 5 Belsize Lane.

BELSIZE LANE / DALEHAM GARDENS – north-west side of Belsize Lane for approximately 10 metres either side of the junction with Dalham Gardens; both sides of Daleham Gardens for approximately 15 metres north of the junction with Belsize Lane.

FITZJOHN'S AVENUE / COLLEGE CRESCENT – west side of Fitzjohn's Avenue for approximately 10 metres north of the junction with College Crescent.

FITZJOHN'S AVENUE / MANSFIELD GARDENS – west side of Fitzjohn's Avenue from the junction with Maresfield Gardens to the southern end of the residents' parking place outside no. 3 Fitzjohn's Avenue; both sides of Maresfield Gardens for approximately 15 metres west of the junction with Fitzjohn's Avenue. HAVERSTOCK HILL / ENGLANDS LANE – south-west side of Haverstock Hill for approximately 10 metres each side of the junction with England's Lane; north-west side of England's Lane for approximately 10 metres south-west of the junction with Fitzjohn's Avenue, south-east side of England's Lane from the junction with Haverstock Hill to the north-eastern end of the residents' parking place at the side of Stanbury Court. HAVERSTOCK HILL / PARKHILL ROAD – north-east side of Haverstock Hill for approximately 10 metres either side of the junction with Parkhill Road.

HAVERSTOCK HILL / UPPER PARK ROAD – north-east side of Haverstock Hill and south-east side of Upper Park Road between the two paid-for parking places at the front and at the side of no. 154 Haverstock Hill. MANSFIELD ROAD / RODERICK ROAD – north-west side of Mansfield Road for approximately 10 metres south-west of the junction with Roderick Road and between the junction with Roderick Road and the southwestern end of the residents' parking place outside no. 20 Mansfield Road; both sides of Roderick Road from the junction with Mansfield Road to the southern end of the residents' parking place and bicycle storage hangar. MANSFIELD ROAD / SHIRLOCK ROAD – south-east side of Shirlock Road from the junction with Mansfield Road to the southern extend of the residents' parking place at the side of no. 40 Mansfield Road.

AVENUE ROAD / ELSWORTHY ROAD / QUEEN'S GROVE – north-west side of Elsworthy Road for approximately 10 metres north-east of the junction with Avenue Road, south-east side of Elsworthy Road between the junction with Avenue Road and the police parking place; north-east side of Avenue Road for approximately 10 metres south-east of the junction with Elsworthy Road, south-west side of Avenue Road for approximately 10 metres south-east of the junction with Queen's Grove; both sides of Queen's Grove for approximately 10 metres south-west of the junction with Avenue Road.

KING HENRY'S ROAD / LOWER MERTON RISE – both sides of King' Henry's Road between the junction with Lower Merton Rise westwards to the eastern ends of the residents' parking places outside nos. 104 and 115 King Henry's Road; west side of Lower Merton Rise for approximately 10 metres north and south of the junction with King Henry's Road.

REGENT'S PARK ROAD / ST. MARK'S SQUARE / PRINCESS ROAD – both sides of Regent's Park Road from the junction with Princess Road / St. Mark's Square westwards to a point in line with the eastern end of the residents' parking place outside no. 36 Regent's Park Road; both sides of St. Mark's Square from the junction with Regent's Park Road southwards to a point in line with the northern end of the residents' parking place outside no. 36 Regent's Park Road; both sides of St. Mark's Square from the junction with Regent's Park Road southwards to a point in line with the northern end of the residents' parking place outside no. 3 St. Mark's Square; both sides of Princess Road from the junction with Regent's Park Road / St. Mark's Square northwards to the southern ends of the residents' parking places at the sides of no. 4 and Vernon House, St. Mark's Square.

BELSIZE ROAD / PRIORY TERRACE – north-west side of Belsize Road for approximately 10 metres either side of the junction with Priory Terrace; east side of Priory Terrace from the junction with Belsize Road northwards to the southern end of the residents parking place outside no. 2 Priory Terrace, west side of Priory Terrace from the junction with Belsize Road north then east around the build-out constructed on the east side of this junction.

WEST END LANE / KILBURN PLACE – south-east side of West End Lane for approximately 10 metres northeast of the junction with Kilburn Place. STATEMENT OF REASONS

To reduce the risk of collisions taking place at junctions in Camden, the council is evaluating the waiting restrictions around all junctions in the borough. The first step in this is to change single yellow lines to double yellow lines. This will ensure that vehicles are not able to park within at least 10 metres of a junction at any time of the day and follows the guidance set out in the Highway Code.

This is part of helping us realise the "Vision Zero" ambition. When we investigated the factors that pose the greatest risk, we found that collisions involving parked vehicles are over-represented in Camden in comparison with other inner-London boroughs. Parked vehicles obscure sight-lines for everyone – those inside and outside vehicles. The data shows that this is a particular problem at junctions for pedestrians, who are twice as likely to be "Killed or Seriously Injured" (an important category in road safety records) as other road users.

The implementation of double yellow lines around junctions will have a beneficial impact on:

- The ease of crossing at junctions, especially for pedestrians
- Road safety helping to reduce the number of collisions involving vulnerable road users
- The quality and accessibility of the street environment."

1. Citation and commencement

1.1 This order shall come into force on and may be cited as the Camden (Waiting and Loading Restrictions) (Civil Enforcement Area) (Amendment No. 123) Traffic Order 2021.

2. Interpretation

- 2.1 In this order;
- 2.1.1 the term "parent order" means the Camden (Waiting and Loading Restrictions) (Civil Enforcement Area) Traffic Order 2012 [L.B.C 2012 No. 1];
- 2.1.2 any reference in this order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment;
- 2.1.3 unless the context otherwise requires, any expression used in this order which is also used in the parent order shall have the same meaning as in that order.

3. Amendments to schedule 1 to the parent order
