Notice is hereby given that the Council of the London Borough of Camden proposes to make the above orders under sections 6, 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the orders are set out below:

ST. EDMUND'S TERRACE (north-west side) – "Waiting and Loading" and "CA-J" amending orders: designation of 24-hour waiting restrictions in the section which lies between its junctions with Avenue Road and Broxwood Way, except where parking places are designated and excluding an 18 metre section outside no. 26 where a prohibition on waiting will continue to apply Mondays to Fridays between 8.30am and 6.30pm. A 24-hour prohibition on waiting including for the purposes of loading would apply at the junction with Avenue Road and Broxwood Way and around the proposed footway buildout outside no. 26a-c. Revocation of the north-easternmost 5.5 metre section of the residents parking place outside nos. 26a-c and designation of a new residents parking place of the same length outside nos. 26 and 27.

These orders would facilitate the introduction of a school safety scheme by Westminster City Council (WCC) in the vicinity of Saint Christina's School in St. Edmund's Terrace and complement similar orders being proposed by WCC on the opposite side of the street which falls within its boundaries.

AGAR GROVE - "CA-N" amending order:

revocation of the westernmost 10 metre section of the paid-for parking place opposite no. 5 and the residents parking place opposite no. 3. Designation of a 10 metre paid-for parking place opposite no. 1 and, adjacent to the south-west, a residents parking place of 10 metres length.

The Camden (Waiting and Loading Restrictions) (Civil Enforcement Area) (Amendment No. 118) Traffic Order 2021

The Camden (Parking Places) (CA-J) (Amendment No. 10) Traffic Order 2021

The revisions to the layout of the parking provision and waiting and loading facilities in the vicinity of Saint Christina's School are necessary to facilitate the introduction of "school keep clear" markings and a kerb build-out outside the entrance to the school.

The "school keep clear" markings will ensure that the kerb-side space outside the school entrance is kept clear of vehicles at the start and end of the school day, thereby improving safety for pupils attending the school. The introduction of the kerb build-out will provide greater visibility for pedestrians crossing at that location and will reduce speeds along that length of road, thereby improving safety for both pedestrians and drivers.

The Camden (Parking Places) (CA-N) (Amendment No. 5) Traffic Order 2021

The relocation of parking spaces in Agar Grove is necessitated by the relocation of a bus stop eastwards. The relocated bus stop will occupy parking spaces designated as "paid-for" parking and a permit holders parking. These spaces will be revoked and similar parking places will be designated to the west of the new bus stop.
