STATEMENT OF REASONS

With the exception of the "CA-Q" amending order, the orders variously revoke or designate parking places to be used by Blue Badge holders or individuals who have demonstrated a need for a dedicated parking place, based on criteria set by the council.

The proposals meet the objectives of Camden Transport Strategy (CTS) which acknowledges that people who have a disability can have particular difficulties when they are travelling by public transport, and walking and cycling may be difficult, unsuitable, or simply not an option.

The orders additionally reduce or increase the lengths of residents parking places depending on whether a disabled parking place is being removed or introduced at that location.

The CA-Q amending order revokes a section of a permit holders parking place in order to replace it with a pedal cycle parking place intended for use by dockless hire bicycles and e-scooters, also meeting an objective of the CTS in promoting sustainable modes of travel.
