RIDGMOUNT GARDENS – cyclists would be permitted to proceed contraflow (i.e. from north-west to southeast). Parking places and waiting restrictions are proposed to be redesignated in Ridgmount Gardens as follows:

East side (from south to north) – 24 hour waiting restrictions (including for the purposes of loading) from the junction with Chenies Street for approximately 10 metres northwards; residents permit holders parking place for approximately 35 metres northwards; 24 hour waiting / loading restrictions for approximately 4 metres northwards; paid-for parking place for approximately 10 metres northwards; residents parking place for approximately 20 metres northwards; 24 hour waiting / loading restrictions for approximately 4 metres northwards; dedicated disabled parking place for approximately 6.1 metres northwards; residents parking place for approximately 23.8 metres northwards; "Green Permit" parking place for approximately 6 metres northwards; 24 hour waiting / loading restrictions Place for approximately 6 metres northwards; 24 hour waiting / loading restrictions parking place for approximately 6 metres northwards; cell disabled parking place for approximately 6.1 metres northwards; 24 hour waiting / loading restrictions for approximately 6 metres northwards; 24 hour waiting / loading restrictions for approximately 6 metres northwards; 24 hour waiting / loading restrictions to the junction with Torrington Place (including the area occupied by cycle hangars)

West Side; 24 hour waiting / loading restrictions to apply from the junction with Chenies Street for approximately 10 metres northwards and from the junction with Torrington Place for approximately 10 metres southwards. The remainder of the east side of Ridgmount Gardens will continue to be designated with a prohibition on waiting between 8.30am and 6.30pm on Mondays to Saturdays.
