#### STATEMENT OF REASONS

#### ARIEL ROAD, BRAMSHILL GARDENS, INKERMAN ROAD, LEIGHTON GROVE, OPPIDANS ROAD

The proposals would see the designation or revocation of disabled parking places either to assist Blue Badge holders in general or for the benefit of specific applicants for individualised parking places. The proposals meet the aims of 'We Make Camden' by improving the quality of life for the user of the proposed dedicated disabled bays, enabling them to live a more independent and active life.

The proposals meet the objectives of Camden Transport Strategy (CTS) which acknowledges that people who have a disability can have particular difficulties when they are travelling by public transport, and walking and cycling may be difficult, unsuitable, or simply not an option.

#### HARLEY ROAD

The removal of a section of a parking place is proposed to enable the construction a vehicular crossover which will provide access to an adjacent property.

#### **CARLOW STREET**

The introduction of a 24-hour prohibition on waiting by vehicles is proposed through the street (except where parking places have already been designated) in order to prevent obstructions by parked vehicles thereby ensuring emergency services can access adjacent properties.
