A number of locations have been proposed for the installation of bicycle hangars and involve the removal of sections of parking places. The provision of bicycle hangars aims to provide secure on-street locations for bicycle storage and the proposed locations are demand-driven and the programme also aims to increase the uptake of cycling by more people.
