CLIFF VILLAS, NW1:

No vehicles will be permitted to wait, including for the purposes of loading or unloading goods in the section between the junction with Camden Park Road and a point approximately 20 metres north of that junction.

ST. AUGUSTINE'S ROAD, NW1:

No vehicles other than pedal cycles will be permitted to enter the section of St. Augustine's Road between its junctions with Camden Park Road and Marquis Road.

YORK WAY, NW1:

Revocation of a 5 metre length of the residents' permit parking place outside no. 103 York Way

CAMDEN MEWS, NW1

No vehicles will be permitted to enter the section of Camden Mews between its junctions with Camden Park road and York Way except for the purposes of access. Vehicles may proceed only in a south-west to north-east direction.

CYCLE TRACK AND PEDESTRIAN CROSSING IN CAMDEN PARK ROAD

Notice is also given under s.65 of the Highways Act 1980 of the council's intention to construct a cycle track on the south-west side of Camden Park Road from a point approximately 12 metres north-west of the junction with Cliff Villas for a distance of approximately 70 metres south-eastwards. Notice is further given under s.23 of the Road Traffic Regulation Act 1984 of the council's intention to re-design the pedestrian crossing in Camden Park Road south of its junction with Cliff Villas. The new crossing will include a cycle crossing facility parallel to the pedestrian crossing point and will require minor amendments to the length of the controlled area marked with zig-zag lines. The proposals are in line with Camden's Transport Strategy 2019-2041, which seeks to encourage sustainable transport and healthier forms of travel, in particular walking and cycling.

Camden Mews

The proposals for Camden Mews are intended to prevent rat-running between Camden Park Road and York Way. Vehicles will continue to be permitted to enter the street for the purposes of access.
